W Fundamental Rights

- ▶ Constitution gives six rights to citizens of India:
 - Equality; freedom of speech; follow any religion; choose any profession; live and travel anywhere in India; free and compulsory education for children up to the age of 14 years.
- ▶ Explain what each of these means when translated into action.
- ▶ Equality of opportunity, pay, wages, work, etc., without caste, gender, colour bias.
- ▶ Freedom of speech does not mean right to be abusive and rude; expressing yourself without hurting the values of others.
- ▶ Follow any religion but not harmful social rituals and codes like sati, dowry, etc.
- ▶ Choose any profession not an illegal or criminal one.
- ▶ Live and travel anywhere in India in order to create a feeling of oneness and unity.
- ▶ Free and compulsory education so that everyone becomes literate.

W Fundamental Duties

- ▶ Constitution expects citizens to perform or abide by ten duties:
- ▶ Follow the Constitution of India
- ▶ Respect the National Flag and the National Anthem
- ▶ Protect the unity and integrity of India
- ▶ Help to defend the country when it is in danger
- ▶ Treat all citizens of India as equal
- ▶ Protect and improve the natural environment
- ▶ Protect and take care of public property
- ▶ Preserve the rich heritage of India
- Avoid acts of violence
- ▶ Work hard for the progress of the country

N Directive Principles

- ▶ These are guidelines for the government of India to ensure the welfare of the people:
- ▶ Provide proper living conditions
- ▶ Provide work for everyone

- ▶ Ensure that some people do not become rich by exploiting others
- ▶ Provide free and compulsory education to all
- ▶ Protect the interests of Scheduled Castes, Scheduled Tribes and Other Backward Classes
